Thank you for your interest in the RN Associate of Applied Science Degree (AAS) nursing program. ## POLICIES AND PROCEDURES

### ADMISSION REQUIREMENTS:

The curriculum in Nursing is a full-time program, requiring a full-time commitment from its students. The faculty of the Department of Nursing strongly discourages its students from full-time employment. Students with financial difficulties should discuss alternatives to employment with the Financial Aid Office. The student's schedule requires a flexible lifestyle as clinical experience is held at area facilities during assigned hours which may be days, evenings, or weekends. Because of this, transportation, childcare, and any employment should be considered prior to entry into the nursing program. Some classes may require more than the scheduled time (i.e. individual practice time in the nursing lab) for an individual student to meet the learning objectives. Students should plan schedules to be able to meet these learning expectations.

### **ACCEPTANCE PROCESS:**

Admission to the nursing program is highly competitive. Only official transcripts submitted by the due date are evaluated. Acceptance into the program is based on data, and grades in the following:

A. Minimum of overall 2.5 GPA (This includes all transcripts and is necessary for the application to be considered.)

B. Points awarded for Grade Point Average of core curriculum (courses that are part of the degree plan):

All applicants will be ranked numerically and placed into available openings according to their rank.

\*\*\*\*Applicants who have taken or enrolled in a science course more than two times and have not earned a grade of C or better will be advised to consider application to other programs. Withdrawals are

counted as an enrollment. A five-year time limit applies to the sciences. The RN Director may review applicant's grades for special admission consideration.

Meeting all criteria and submitting an application does not guarantee admission into the nursing program. The number of students admitted will vary according to resources available prior to registration.

Students must meet all admission requirements and resubmit a new application for admission to the nursing office to be considered for enrollment in the next class. The student will be subject to any revised standards and requirements in effect at the time of re-application or re-entry.

Students who are notified that they are on the alternate list but are not accepted must re-apply if they seek enrollment into nursing courses the next year. Alternate status does not mean that the student will be ranked higher for the next application period. Students must meet all admission requirements and resubmit a new application for admission to the nursing office to be considered for enrollment in the next class. The student will be subject to any revised standards and requirements in effect at the time of re-application. Alternate students should seek the advice from a counselor or the director of the nursing program in regard to improving their chances of acceptance.

Students who withdraw from Nursing 1107 or Nursing 2158 for any reason must again meet eligibility requirements and reapply for admission.

**Falsification of any information in the application process may result in dismissal from the program.**

**\*Non-English-speaking students shall meet the same admission criteria as other students and pass an English proficiency exam.**

### **Computer Requirements**

Ipads are highly discouraged and are not allowed for ATI exams.

All examinations will be administered via ATI or ExamSoft's Exemplify software using the student's personal laptop computer. Chromebooks, iPads, Android, Linux or tablet operating systems are not compatible for testing purposes. Students are expected to take each exam on a supported computer with functioning camera and microphone. Students must ensure adequate system requirements to use ExamSoft and ATI prior to the start of the nursing courses.

### **RESPONSIBILITIES UPON ACCEPTANCE**

Once offered a position in the nursing program, the student is responsible for:

- A. returning completed RN Health Statement, and Technical Standards as acceptance, see appendix B. Failure to meet the Health & Technical Standards or provide immunizations will result in forfeiture of admission.
- B. ensuring immunizations are current for the duration of the program. Students who are not in compliance with these requirements, will be unable to meet clinical requirements and will be dropped from any nursing course. The following must be submitted before orientation:
- **Hepatitis B** -- consists of 3 injections over a 6-month time-period or laboratory result verifying immunity, Hepatitis B Surface antibody. Two of the 3 injections must be completed prior to the first day of clinical. Arrangements for the first injection must be made immediately and followed with the second one month after the first injection. The third injection of the series must be given 6 months after the first injection. Continuation in the program is contingent on providing proof of the third injection.
  - **Tdap** – The Tetanus, Diphtheria, Pertussis (Tdap) immunization is needed every 10 years to remain protected.
  - **TB** – Two negative TB test (within the last year) must be on record. The TB test must remain current throughout the program. If a negative TB test cannot be provided, a certificate of health or physicians statement that the student is disease free must be provided yearly to the nursing program. A blood test such as QuantiFERON Gold is also accepted. Traditional RN students most recent TB must be valid through May, Bridge RN students most recent TB must be valid through December.
  - **Varicella** – verification of 2 injections must be provided or laboratory result verifying immunity, Varicella Zoster IgG antibody.
  - **Influenza** vaccination – is required for all clinical sites. Traditional RN students will receive after starting the program. RN Bridge students must submit proof before orientation.
  - **Covid vaccination** – NorthArk does not require students to receive or report their COVID-19 vaccination. Students who are assigned to clinical facilities must comply with the established COVID-19 clinical procedures and guidelines for their assigned facility and, for those that require COVID-19 vaccinations, students must submit vaccine documentation. Please note that refusal to comply with all the vaccination requirements may limit site placement and could impede progression through your program of study.
  - **CPR** -- provide current documentation of certification in cardiopulmonary resuscitation (CPR) “HeartCode Basic Life Support” from the American Heart Association. Students must maintain certification throughout the program. If the current certification expires prior graduation, then a new certification is required before the start of the program.
- C. agreeing to complete a 10 Panel UA Drug Screen. The date and time of the drug screen will be announced once the initial nursing semester has started. The drug screen may be administered at any time, without warning to the student. A student taking any prescription drug that will or may show up in a drug screen must be able to produce a valid drug prescription in their name, filled within the last 6 months. If the screen comes back positive or if the student refuses a drug screen, the student forfeits their place in the program. Students unable to void after 3 hours will be considered a refusal and will be dismissed from the program.
- D. agreeing to a criminal background check prior to clinical experience. The Nursing and Health Professions students are required to undergo Criminal Background Checks prior to participating in any clinical experiences. Details for background checks will be given during orientation. North Arkansas College has an arrangement various companies to provide this service to all nursing students and includes screening searches of: County court records, FACIS 1 (OIG, GSA, & other federal sources). ID Trace Pro (current/previous addresses, SSN valid/deceased, aliases, high risk fraud alert), National Criminal Database. National Sex Offender Public Registry.
- E. If for any reason (Criminal Background, previous employment, etc.) a clinical site will not allow the student to attend clinical, then the student will not be able to fulfill the clinical requirements the program and will be dismissed from the program.

## CRIMINAL BACKGROUND CHECK

Students should be aware that all persons seeking initial licensure as a nurse are required to undergo a federal and state criminal background check which requires fingerprinting. The practice of Nursing is regulated by the Arkansas State Board of Nursing, which has the mission to protect the public and act as a public advocate. The Board outlines the conditions in which a newly graduated RN student may apply for an Arkansas license. Even though students may complete a program of study in an RN degree program, this is not a guarantee that the student will be allowed to test or receive a license. All persons seeking initial licensure as a nurse in Arkansas are required to undergo a federal and Arkansas criminal background check. If an applicant has pleaded guilty, nolo contendere to, or been found guilty of any offense listed in ACA §17-3-102, he/she is not eligible for Arkansas licensure. ACA §17-3-102 provides an opportunity to request a waiver of eligibility criteria related to a criminal background in certain circumstances.

If you need additional information, contact the RN Program Director. If the student is seeking licensure in another state besides Arkansas, the student should contact the State Board of Nursing in which the student is applying for licensure.

If the student has plead guilty or been convicted of a crime, the student must notify the Director of Nursing at the time of application. This is necessary even if the student's criminal record has been expunged.

(c)			The applicant shall sign a release of information to the board and shall be responsible to the Division of Arkansas State Police for the payment of any fee associated with the criminal background check.
(d)			Upon completion of the criminal background check, the Identification Bureau of the Division of Arkansas State Police shall forward to the board all releasable information obtained concerning the applicant.
(e)			For purposes of this section, the board shall follow the licensing restrictions based on criminal records under § 17-3-102.
(f)	(1)		The board may issue a nonrenewable temporary permit for licensure to a first-time applicant pending the results of the criminal background check.
	(2)		The permit shall be valid for no more than six (6) months.
(g)	(1)		Any information received by the board from the Identification Bureau of the Division of Arkansas State Police under this section shall not be available for examination except by:

## PROGRESSION

To progress in the nursing program, a student must meet and agree to the following guidelines:

A. The nursing curriculum requires that the nursing courses be taken in sequences with the expectation of building on prior learning.

B. Maintain an overall grade point average of 2.0

C. Achieve a grade of "C" or above in the theory component of all Nursing courses.

### Grading System

100-90.5 = A

90-83.5 = B

83-78.5 = C

78-69.5 = D

Below 69.4 = F

D. Perform safely and ethically in all nursing course work.

E. The assignment grade will be applied only after the student has attained a score of 79% or higher on all examinations. If a student's average on unit exams and the final exam is below 79%, they will not advance in the program and the homework grade will not be added. If the total exam average is greater than 79%, the assignment grade may lower the final course grade to below 79%, resulting in failure of the course.

F. Achieve a "satisfactory" in the clinical component of all courses titled Nursing that have corresponding hospital or laboratory experiences. If student is unsuccessful in clinical, the theory grade (if higher than a "D") is automatically lowered to a grade of "D". Students cannot progress in the program.

G. Earn a grade of "C" or above in each course required in the nursing curriculum. Graduation from the nursing program requires a minimum grade of "C" or better in all courses required in the nursing curriculum.

H. Satisfactorily complete all academic prerequisites listed in the degree plan.

I. Must have mental and physical health sufficient to maintain expected program activities. Students with changes in their health after admission, must present a health release from their physician to continue in their clinical nursing course. (examples: pregnancy, surgery, hypertension, etc.)

J. May re-enter the program one time by compliance with the readmission criteria.

K. Must complete the entire program within (5) five years after admission to the nursing program. If the program is not completed within five years; students may be asked to repeat some nursing and science courses.

L. All nursing courses must be dropped if a student is unsuccessful (below 79%) in any nursing course during the semester.

M. Understand that nursing courses cannot be audited.

N. Math Exams in the Registered Nursing Program: Due to the potential for safety errors when administering medication, the RN Program has established the following math exam competency policy.

### **Traditional RN Program**

Students will be given a math exam during NURS1107 Fundamentals of Nursing and during NURS 2128 Medical Surgical Nursing III. The content covered on the exam will be equitable to the math concepts that will have been covered up to that point in the course(s). The student must pass the math exam with a 90% or greater score. The student may take the exam 3 times. A different exam will be given each time but will cover the same content. If the student does not pass the math exam on the 3<sup>rd</sup> attempt with a 90% or greater, then they will be dismissed from the program. The student is responsible for reviewing the exam and seeking out remediation resources before taking the exam for a second or third time.

### **RN Bridge Program**

Students will be given a math exam during NURS2158 Nursing Process I and during NURS 2178 Nursing Process III. The content covered on the exam will be equitable to the math concepts that will have been covered up to that point in the course(s). The student must pass the math exam with a 90% or greater score. The student may take the exam 3 times. A different exam will be given each time but will cover the same content. If the student does not pass the math exam on the 3<sup>rd</sup> attempt with a 90% or greater, then they will be dismissed from the program. The student is responsible for reviewing the exam and seeking out remediation resources before taking the exam for the second or third time.

### **ACADEMIC/PROFESSIONAL IMPROVEMENT AND DISMISSAL**

To complete each nursing course students must fulfill both academic and professional requirements. Professional standards are demonstrated by students when they consistently meet standards described in the Arkansas Nurse Practice Act, the American Nurses' Association Code of Ethics, and the National Student Nurse Association Code of Academic and Clinical Conduct. Professional standards also apply to classroom behavior and any instance when the student represents the nursing program of North Arkansas College. Students who fail to meet course, department or college policies may be placed on an improvement plan.

Students will be informed of behaviors/performances inconsistent with program expectations as well as professional nursing standards and will be placed on an improvement plan as follows.

- A. Verbal Improvement Plan: Students exhibiting minor, correctable, isolated unprofessional behavior will be given a verbal improvement plan that is to be documented. Documentation will include constructive feedback for modifying behavior(s) to meet professional standards. This does not require a student's signature. This form will be placed in the student's file. The faculty initiating the behavior improvement warning will inform the course coordinator. The student is expected to modify the behavior accordingly. If the behavior is not modified or if new unprofessional behaviors arise, a signed written improvement form will be initiated.
- B. Written Improvement Plan: Students exhibiting repeated or multiple minors, correctable unsatisfactory professional and/or personal behaviors, and/or academic performance issues, require written notification. The behavior(s) will be documented on the Improvement Form. The faculty initiating the improvement form will review the identified academic/professional problem. The student will document their plan of action to correct the issue and both will sign and date written notification. The form will be placed in the student's file and a copy given to them. The

faculty initiating the behavior improvement plan will inform the course coordinator. The student is expected to modify the behavior accordingly.

- C. If a student continues to demonstrate the unsatisfactory professional and/or personal behaviors, and/or academic performance issues, the student may be dismissed.

D. Dismissal

A student will be dismissed from the Registered Nursing Program for the following:

1. have earned a "D" or "F" in any nursing course
2. have earned a "D" or "F" in two required non-nursing courses.
3. excessive absences or tardiness as stated as stated in the attendance policy
4. breached confidentiality of the patient, the family, or the agency
5. Participates in one or more of the following:
  - a. misrepresentation or falsification of yourself or another student, as well as patient and/or agency records
  - b. sexual harassment
  - c. engages in sexual relations with a patient when a generally recognized professional relationship exists
  - d. act or threat of intimidation, harassment, or physical aggression
  - e. illegal possession, sale, or distribution of prescription or illicit drugs.
  - f. Illegal possession of weapons
  - g. unauthorized possession of examinations
  - h. plagiarism
  - i. theft
  - j. academic cheating, dishonesty, or misconduct
  - k. failure to exhibit acceptable professional behavior or any other activity which is incompatible with professional behavior as indicated in the Code of Ethics for Nurses (Appendix A).
  - l. failure to exhibit safe clinical practice according to the National Student Nurse Association Code of Academic and Clinical Conduct
  - m. activities which are determined to be dishonest, inconsistent with professional responsibility and accountability, and/or may be detrimental to the protection, safety, and welfare of patient and the public or in any situation when representing the Registered Nursing Program of North Arkansas College.
  - n. no call – no show. See Attendance Policy
6. Positive drug screen without a valid prescription.
7. Refusal to submit to a drug screen

E. Petition for Exception

Students who have been dismissed for program policy violations may file a petition for exception. Petition for exception is made to the Director of Nursing. During the petition process, students may continue to attend class and/or clinical at the discretion of the director. After thorough review by the director and faculty the petition is voted on by all full-time faculty. The student may be dismissed or allowed to return to the program with strategies or assignments to improve performance. Students readmitted following a petition for exception will be placed on departmental probation. The terms of departmental probation will be defined by faculty and related to the specific incident.

**If a student has been dismissed from the program, they may be ineligible for readmission depending on the circumstances of the dismissal.**

## F. Academic Grievance

The Registered Nursing Program works with the students in finding fair and just solutions to problems, including any student grievance, appeal, question, misunderstanding, or discrimination.

Students may file a grievance according to the North Arkansas College grievance policy that follows:

### Academic Grievance.

1. If a student has a complaint about an academic issue, he or she will go to the instructor to file a complaint.
2. If the instructor is unable to resolve the issue, the student will go to the chair or program director of the department (RN Program Director).
3. If the chair or program director is unable to resolve the issue, the chair will inform the student they have the right to start a grievance process, beginning with the completion of NorthArk Feedback Forum. Upon completing basic information on the form and pressing Submit, the form will go to the Dean's Administrative Assistant, who will then forward it to the dean, informing the student to make an appointment with the dean to discuss the matter further. (Dean of Health Professions).
4. Should the student be unable to resolve the grievance with the dean, he/she may then within five class days of speaking with the dean, request the grievance go to the Academic Grievance Committee facilitated by the Vice President for Academic Affairs.
5. The decision of the Academic Grievance Committee will be communicated to the student within five days. The decision of the Committee is final.

## G. Non-Academic Grievance

Any student who believes an injustice or a violation of state, federal, or college policies, laws, or regulations have occurred should try to resolve the problem through informal consultation with the individuals indicated below, in order, before filing a formal grievance.

- Individual or staff member involved
- Appropriate supervisor of the staff member involved
- Appropriate Dean of the staff member involved

If the student has been unable to resolve the issue, the student may file a formal grievance within five business days by completing the electronic Feedback Forum form located on the website homepage. This completed form is submitted to the appropriate department head for a final attempt at a resolution. If no resolution can be obtained, the issue is presented to the Institutional Standards and Appeals Committee. The Institutional Standards and Appeals Committee, whose decision is final, will notify the student within five business days of their decision. Policy: Non-Academic Grievance.

## **READMISSION**

Re-admission to the nursing program is not automatic and all initial admission criteria applies.

### A. Students can be readmitted to the program providing:

1. reentry allows for completion within 5 years from start
2. the student must repeat all co-requisite nursing courses of the semester they withdrew from to ensure preparation for taking the NCLEX-RN exam.
3. there is available space in the next class.
4. student submits a letter of desire to the RN Director in writing (paper or e-mail) at least 3 months prior to the semester being re-applied
5. student passes the re-entry exam with 79% or higher
6. student performs clinical skills test applicable to the content. After planned practice in the simulation lab, the student must pass the skills test on the first try.

7. must have a 2.5 overall grade point average.
  8. the student is accountable for changes in the degree requirements at the time of readmission.
  9. the student must meet all academic, professional, and health requirements in effect at the time of readmission.
  10. Students who have been dismissed for academic integrity or behavior problems are required to take Northark FYE Course before being readmitted.
- B. Students unable to return within 5-year completion OR students who did not successfully complete the first semester, will need to re-apply, go through the selection process, and take the entire nursing curriculum. The applicants who have previously been admitted to the RN program and failed will be placed on the alternate list for the RN and RN Bridge programs (NURS 1107 & NURS 2158).
- C. Students are allowed one (1) readmission into the program. This applies whether the student withdrew previously in good standing, not in good standing, or not successfully completing a semester.
- D. If a student receives an unacceptable grade (D or below) in a nursing course or withdraws without completing the course work, that student may reapply to the program for the acceptable point of re-entry or reapply to NURS 1107 Fundamentals of Nursing or NURS 2158 Nursing Process I. Example – if the student is enrolled in Medical Surgical Nursing I and is unsuccessful then they may re-apply to the course one time or re-apply to the program again.

## **GRADUATION**

The Associate Degree in Nursing is awarded to students who:

- A. earn 66 credits (Traditional RN Class) or 63 credits (RN Bridge Class) with a cumulative grade point average of 2.00 or above.
- B. earn a "C" or above in all courses required in the nursing curriculum.
- C. fulfill all nursing program course requirements.
- D. file an application for graduation form with the Registrar's Office within the specified time limits.

The Health Profession Graduation and Pinning Ceremony celebrates the RN graduate's accomplishment and welcomes the new graduate to the profession. This time-honored tradition marks the transition from student nurse to graduate nurse and is, typically, an emotional event to share with family and friends. The ceremony is combined with other allied health professions.

- Date, Place & Time: Designated by college and is published with the academic calendar.
- Dress: cap and gown provided by the college.
- Graduates march into the ceremony led by faculty members.
- Pinning: each member of the graduating class selects a program faculty member or a special registered nurse to place the pin on his/her uniform. Only an RN may pin the student.
- The class recites the Nightingale Pledge as a professional statement of the nurse's mission and values. The Gideons, Int. will provide a "Nursing Testament".
- Graduates are presented and guests invited to a reception in the Bradley Student Center.

## **TRANSFER**

A transfer student is defined as one who has successfully completed one or more nursing courses at another college with at least a letter grade of C. Applicants who have not been successful in another nursing program are not eligible for transfer into upper level nursing courses. They may apply for admission to NURS 1107 or NURS 2158. Transfer students must pass the entrance exam with a 79%

or higher; and skill test commensurate with the level of entry that they are applying to. After planned practice in the simulation lab the student must pass the skills test on the first try. Transfer students must meet all the admission criteria and will be considered on an individual basis by the director of nursing after review of transcripts. Placement is based on available space. A letter of reference must be received from the Director of the Nursing program in which an applicant has been attending. The reference form will be sent directly to the RN Program Director. This applies to any health profession program that a student has attended in the past. If the applicant does not receive a positive reference from the previous nursing or health profession program, then they will not be considered for a position in the NorthArk RN Program. Each applicant's status will be reviewed by the RN Program Director and advised for possible entry or transfer into the program.

### **CLINICAL FACILITIES**

The nursing student is required to spend a predetermined number of hours in the clinical setting. Clinical rotations may include skills labs on campus, various area hospitals, simulation in the campus Health Education Simulation Center, physician's offices, mental health agencies, public schools, nursing homes, community health settings, etc.

The student, upon admission to the program, must be available to attend any of the nursing course's scheduled clinical days and/or clinical sites. This may include evening shift or weekend experiences. Transportation to these facilities is the student's responsibility and student must have access to a safe, reliable motor vehicle during their clinical studies. Travel arrangements, living accommodations, meals, and similar expenses that are associated with clinical assignments are the responsibility of the individual student.

Due to unforeseen circumstances, it is at times necessary for students to change to another clinical site other than the one which was originally scheduled. The RN Program reserves the right to schedule clinical experiences as they become available in area hospitals or other area facilities. The RN Program will communicate with students as early as possible regarding clinical changes.

## REGISTERED NURSING PROGRAM TECHNICAL STANDARDS FORM

The provision of safe patient care necessitates the student's ability to respond to multiple sensory and environmental cues. It is essential that the student be able to read, understand, and apply the information in nursing textbooks, and clinical records. It is essential that the student be able to effectively communicate with patients, families, and peers. The student must be able to tolerate stressful and physically taxing workloads. The student may be exposed to communicable or infectious disease, hazardous materials, and injury from performance of assigned duties.

- Communication             Communicate effectively, both orally and in writing, using appropriate grammar, vocabulary, spelling, and word usage with patients, families, and co-workers.
- Perform mathematical calculation for medication preparation and administration.
- Demonstrate basic computer/information technology skills.
- Must be able to demonstrate the ability to complete assignments within an allotted timeframe.

- Vision                     Perform close and distance visual activities involving objects, people, and Paperwork, as well as discriminate depth and color perception.

- Hearing                  Respond and react immediately to auditory instruction, request, and/or monitor equipment; perform auditory auscultation without auditory impediment.

- Motor Skills             Lift and transfer patients up to 6 inches from a stooped position, then push or pull the weight up to 3 feet.
- Lift and transfer patients from a stooped to an upright position to accomplish bed-to-chair and chair-to-bed transfers.
- Work in a standing position and walk frequently.
- Apply up to 10 pounds of pressure to bleeding sites, or in performing CPR.

- Psychological Skills    Perform up to twelve-hours in a clinical/laboratory setting.
- Be able to tolerate various odors.

- Must be able to use critical thinking skills to interpret and evaluate patient data.

- Perform effectively and professionally in a stressful environment/situation.
- Work well with others.

# North Arkansas College 2024 Annual State of the RN Program

The RN Nursing department offers a program leading to the Associate of Applied Science degree (A.A.S.). The program is fully accredited by the Accreditation Commission for Education in Nursing (ACEN) through Spring 2029. Approval of the program with Arkansas State Board of Nursing (ASBN) is through 2026.

## GRADUATE SUCCESS ON THE LICENSING EXAM:

Our goal is that our graduate's pass-rate for first-time takers of the National Council Licensure Examination for Registered Nurses (NCLEX-RN) for all first-time test taker will be at or above 80%. NCLEX pass rates were lower for students who began the program during covid and remote instruction. Faculty continue to research and use evidence-based teaching methods in the classroom and clinical for optimal learning. The Next Generation NCLEX began in April 2023 and has contributed to improved pass rates nation wide.

## STUDENT RETENTION OR COMPLETION RATE:

Our goal is to have a completion rate of 60%. This means that 60% of the students that begin the program will complete the program on time. Analysis demonstrates upward trend in retention. Faculty are heavily vested in student success through coaching and mentoring students. The program added a peer mentoring program in 2022.

Our goal is that 93% of graduates responding to the Post-Graduate Survey, 6 months after graduation report employment as a Registered Nurse.
